TUITION ASSISTANCE POLICY

Tuition Assistance / Grant Requests

We sincerely strive to do whatever we can to help families where needs exist. Each year our school has a limited amount of tuition assistance funds that are available to help families who demonstrate additional need beyond the already discounted tuition. Priority is given first to current families and to those who demonstrate the greatest need. These grants are available only to those who go through the financial assistance process.

We use a third-party service – FACTS Grant & Aid Assessment - for the determination of each family's financial need. The information that you provide on the "Tuition Assistance Application" will generate a confidential report by FACTS which will then be sent to our JCS Financial Grant Committee. This report will provide a recommended amount of assistance; however JCS will make the actual grant determination.

Steps for Applying

1. Complete and sign the "Grant Application" form and *return to the school*.
2. Complete the "FACTS Grant & Assessment" and mail to FACTS with the required fee.

Arizona Tax Credit Opportunity for Kindergarten through High School
